

# Terms of Use

Welcome to the Special Olympics Connect website (Connect). Connect is owned and operated by Special Olympics, Inc. (SOI), an international non-profit organization incorporated in Washington, D.C., USA.

The terms and conditions below govern your use of Connect. Please read these carefully before using Connect. Your use of Connect indicates that you accept these terms. If you do not agree to these terms you must not use Connect.

## **Our Intellectual property rights**

SOI owns or is licensed to use all intellectual property rights in and to Connect and all technical infrastructure (the software) relating to it. If you breach any of these terms your permission to use Connect and any materials or content included in it, automatically terminates and you must immediately destroy any downloads or printed extracts from Connect.

## **Access to and use of Connect**

In accessing any part of Connect, you agree:

- Not to use Connect in such a way that disrupts, interferes with or restricts the use of Connect by other users;
- Not to upload, display or transmit any materials through Connect which are false, offensive, defamatory, threatening, obscene, unlawful or which infringe the rights of any other person anywhere in the world;
- Not to reverse engineer, decompile, copy or adapt any software or other code or scripts forming part of Connect or attempt to transmit to or via Connect any information that contains a virus, worm, trojan horse or other harmful or disruptive component; and
- Not to change, modify, delete, interfere with or misuse data contained on Connect and entered by or relating to any third party user of Connect.

## **Users of Information**

If you are granted permission to log-in and access Connect to download information (the Material), you may do so only for purposes authorized in advance in writing by an authorized representative of SOI or another Special Olympics organization (the Purpose).

You shall indemnify and hold harmless SOI and all other Special Olympics organizations, their officers, directors and employees from all loss, cost, damage, liability and expense, and reasonable attorneys' fees that they may incur by reason of your use of the Material in any manner not authorized by these Terms of Use.

You shall have no rights to the intellectual property or the software, or any enhancements or modifications thereto, provided to you in order to access Connect Material. You may not sublicense, assign or transfer any licenses granted by SOI, and any attempt at such sublicense, assignment or transfer shall be null and void.

### **Users who are posting and submitting material**

SOI may at its discretion allow users to upload or post content to individual user pages or to certain areas of Connect (each a Submission). SOI may in its sole discretion decide whether or not to use a Submission. SOI is hereby licensed to edit, change and remove all content posted to Connect. You represent, warrant and agree that you will not provide any Submission which is subject to the rights of another person without first obtaining their express authorization and that you are responsible if your Submission injures another person.
